This shows that the Joint Business Group in Kemlagigede Village needs to be fostered and developed so that there is an increase in the activity and productivity of the Joint Business Group as a catalyst for driving the village economy.

One of the Joint Business Groups in Kemlagigede village, Turi District, Lamongan Regency is KUBE MANDIRI SEJAHTERA. This Joint Business Group has been active since early 2020, and started operating with capital of IDR. 10,000,000,- with 20 members. Currently, the Joint Business Group is utilizing all of this capital to provide its members with capital to start businesses and develop existing businesses using a capital loan system from KUBE Mandiri Sejahtera. This business was chosen because all the members of Kube Mandiri Sejahtera are mothers and most of them do not have additional income apart from their husbands who are agricultural laborers. Considering the strategic role of the Joint Mandiri Sejahtera Business Group in Kemlagigede village, of course it is not enough to just rely on this business which has very slow capital turnover, while there is still a lot of other potential that can be developed in this village, so it is necessary to develop other businesses that are economically profitable. However, to develop this business requires the readiness of the Joint Business Group management to explore and assess the feasibility of the business to be developed, including efforts to attract cooperation from external parties, both government and private.

Based on this background description, academic assistance is needed for Joint Business Group managers in developing their managerial abilities through Technical Guidance for Joint Business Group Management, by providing understanding and transfer of skills in making Joint Business Group Business Feasibility Studies (SKB).

RESEARCH METHODS

This community service activity was carried out in the Mandiri Sejahtera Joint Business Group (KUBE) Kemlagigede Village which is engaged in the credit business. This community service activity is carried out by providing counseling and technical guidance for preparing financial reports for business feasibility studies in the Bersama Kube Mandiri Sejahtera business group. The implementation of activities can be explained as follows: a. Initial survey conducted to find out the obstacles faced by partners. b. Preparation Stages: Preparation for this activity includes several procedures, namely preparing materials, preparing activity equipment, arranging licensing documents. c. Implementation of activities, actions or implementation of technical guidance for preparing business feasibility study reports. d. Evaluation, after implementing the activity, the team carries out an evaluation with the following activities: seeing the results of the report that has been made whether it is in accordance with the partner's situation and reviewing what needs to be improved and re-evaluating.
